

cause it fails to provide for its basic functional principle. Our laws, regulations and directives should only protect the individual American from interference by other individuals in their rights of life, liberty, and the pursuit of happiness as well as our Bill of Rights in our Constitution. No one has the right to implead any American from the full enjoyment of their liberties in any manner unless their actions directly inhibit the same rights of other Americans. In other words, the function of law is to protect us from harmful actions of other people. Therefore, for a law to be valid, there must be a victim in each case of violation unless the law provides for common welfare, such as tax laws, where the entire society is the victim.

Our Legal System is dysfunctional because it functions on the theory of inertia. For example, many Florida counties and cities have ordinances prohibiting the sale of alcohol at various times on Sunday. The laws originated in the 19th century to prevent cow hands and agricultural workers from getting drunk on Sunday morning then showing up drunk for church services. This is no longer a problem, yet the law is still enforced. Please do not forget that not all religions hold services on Sunday.

Laws can outlive the problem for which the laws were created to solve. When I was in the US Army, I was assigned a short tour, normally 12 months, to Korea. When I arrived in Korea, the Army informed me that my tour would be 13 months by regulation. When I asked why they added the additional month, they said it originated in the 1950's when soldiers would travel to Korea by ship. It took the ship two weeks to travel one way between the US West Coast to Korea. In 1972, the trip by airplane was just longer than one day.

Our Legal System also functions on the principle of legal precedent. If a judge decides on a specific case at any time in our history, a lawyer can cite this decision as a reason for a current judge to decide in an analogous manner a case now. Since societies and their problems change with time, this can also create the problem of invalid inertia and faulty judgments. The solution is to create a Supreme Court panel of judges who review local, state, and federal law. They could void out-of-date and unconstitutional laws, clearing the books.

The First Amendment to our Constitution prohibits making laws favoring any one religion, yet many laws at the national, state and local levels do favor religious views of one or more religions. The Amendment also protects Americans who do not believe in any religion. Our religious laws usually have no victims.

They are therefore unconstitutional and should be removed from our legal system.

While I am a Christian and believe applicable principles of the Bible, secular laws created on specific religions create additional problems. The Bible, the Koran and other religious texts were written hundreds to thousands of years ago. Our society and scientific progress have drastically changed as have the problems of protecting individuals in each society. For example, in Biblical times, slavery was an established institution, and women were treated as private property with little to no rights.

The Bible instructs slaves to obey their masters, while in our current society, we consider slavery highly illegal. We believe that no one person has any right to own another person for any reason. The ownership of a person violates the basic principle of law stated previously in this article.

The Bibles treatment of women does not match the realities of our present society. Women were the property of their father until their father gave them to their husbands. This ritual is still followed today in marriage ceremonies. When I married my wife, she promised to obey me as a part of her vows. Given today's freedoms, she broke the vow quickly with no objection from me.

Doweries also involved ownership. When a husband accepted ownership of his wife, he also accepted responsibility for providing support for an additional member of the family who, at that time, did not work outside of the home. The father, on the other hand, was relieved of his daughter's support burden. Hence, the father compensated the husband by giving him a dowry.

The Biblical Jewish Legal system is the basis for most other religious beliefs concerning marriage and women. Women were the property of their father or husband. Women could not hold any position of responsibility or outside job for that matter. Lacking any form of birth control, a man who has relations with a woman could produce a child. A man who has relations with a woman who was not his wife suffered punishments based on the status of the woman. If she was unmarried and not engaged with any other man, then the man was required to marry her. If the woman was engaged or married, both the man and woman suffered death. If the woman did not belong to a family, then what happened to the woman was based on the married status of the man. She was stoned if he were married, but what would have happened if he was single is not clear since there was no father/husband to file charges. What

is strange under this system is that prostitution was common. The entire system existed on the fact that there was no birth control and children conceived by a wife were the financial responsibility of the husband. A man did not want to be responsible for another man's child.

The status of women in our society has completely changed. People are considered equals in every aspect. With the existence of modern birth control, the possibility of intimate relationships producing children has almost vanished. Yet, the laws against adultery still existed until recent time and still exists in our military law. Laws against prostitution still exist, yet there is no actual victim except in the cases of white slavery and child exploitation.

The final reason for our dysfunctional legal system is the efficiency of our court process. For example, in our specific case against Iran and Sudan, the bombing occurred on August 7, 1998. Our lawyer was not able to file a viable case until just after 9/11. The final verdict in our favor did not occur until 2011, and we are still in the process of collecting on that verdict.

Our court system is simply too slow, so we should follow other modern countries' examples. For instance, when we were in Geneva, Switzerland from 1986 to 1989, airline hijackers landed in Geneva and the police captured them the same day. Their trial occurred the day after they landed. On the second day, they were in prison serving life sentences.

A major problem slowing down our court system is the abundance of frivolous cases clogging the system. We need a pre-case system, where cases are examined by legal panels to decide if the case should be dismissed, sent to binding arbitration or forwarded as a normal case. This would weed out trivial cases vastly improving the processing of the court's docket.

The courts should work eight hours a day, five days a week like the rest of us. They can also reduce the normal two-hour lunches to one hour. Any additional work after hours should be homework like the rest of us do. This also applies to the appeals process. Hold the hearing, decide, write it up and send it by electronic means to the parties involved and the lower court. Victims would receive justice in a timely manner.






